5. The owner understands that at times during his/her pets stay at Shuswap Pet Resort, the owner's pet may be in contact with other pets to facilitate socialization. The owner of the pet understands and agrees that Shuswap Pet Resort is not responsible for any injuries or illnesses as a result of this socialization.
6. The owner of the pet certifies all required vaccinations are current (please refer to Shuswap Pet Resort policies).
7. Shuswap Pet Resort lies within the ALR therefore, occasional use of pesticides, herbicides fertilizers, minerals etc. may be used by the owner's/leases of such land. Shuswap Pet Resort is not liable for any loss or expense that may be shuttered or bared as the result of any of the above use.
8. Shuswap Pet Resort reserves the right to refuse service to any client.

## Shuswap Pet Resort Policies And Procedures

Shuswap Pet Resort strives to be the “home away from home” for your pet. Our vision is to provide a safe and fun environment for you pet.

1. All pets are required to have a completed and current registering on file before attending Shuswap Pet Resort.
2. Vaccinations must be fully up to date and owners must submit a written proof of list requirement.
  - A. DOGS: Distemper (CDV), Parvovirus (CPV), Infectious Hepatitis (ICH), have a vaccination against Rabies and be on a flea/tick/lice prevention program.
  - B. CATS: Feline Paleukopenia (Distemper, FPV), Feline Viral Rhinortacheitits (FVR) Feline Calicivirus FCV.

We strongly urge you to have a vaccination against Rabies and be on a flea/tick/lice prevention program.

3. Owners are required to sign the waiver form and the policies and producers forms before their pet attends Shuswap Pet Resort.
4. All pets must be in good health. If your pet has had a communicable disease or condition (diarrhea, vomiting, etc.) in the last 30 your pet will not be accepted at Shuswap Pet Resort without a veterinarian’s certificate of clean health.
5. If your pet requires medication the staff will administer it as your Instructions and free of charge. Administration of medicine is limited to topical or oral administration. The owner’s request for the administration of all medication to his/her pet is at their own risk.
6. Shuswap Pet Resort accepts all puppies and kittens that have their third set of vaccinations completed. All cats must be spayed or neutered. Dogs may attend unaltered at the owner’s risk. No females in heat will be accepted
7. All pets must be leashed or properly caged when entering Shuswap Pet Resort including the parking lot.
8. If after five days a pet has not been picked up or the owner refuses to pay, Shuswap Pet Resort will transfer the care of the pet to the local SPCA
9. Reservations: Please contact the resort. Payment is due at the time the owner picks up his/her pet. Method of payment is either cash or cheque.
11. Rates: Various packages are available to meet all your needs and desires. Please refer to our brochure. Gift certificates in various denominations are available upon request.
12. Hours Of Operation: Seven days a week: 7:00am-6: 30pm We will try to accommodate your travel itinerary.
